2010 CHAMPIONSHIP SINGLES TOURNAMENT RULES

1. Polk County 500 Club Singles Tournament will be a 3-game USBC-certified tournament conducted no earlier than 1:30 p.m. Sunday, May 2, 2010, at Orange Bowl Lanes, 4318 U.S. 98 North, Lakeland. (863) 858-3878. Handicap will be 100% of 200.
2. Only members of the Polk County 500 Club will be eligible to participate. All bowlers must hold a current USBC membership card and must show this card at check-in.
3. Entry fee is \$16.00 per bowler: \$7.25 for bowling; \$1.25 for expense; \$7.50 for the prize fund. Prize fund will be distributed at 100% based on 1 out of 5 entries. Winners will receive checks within 14 days after end of tournament.
4. Pre-entry deadline is Tuesday, April 27, 2010. Entries also accepted at tournament site up to 12:45 p.m.
5. Entrants will use their highest yearbook average from the Orange Belt USBC Bowling Assn. If no yearbook average, entrant will use their highest league average of 21 games or more as of January 1, 2010. All others will bowl scratch. Tournament director will verify averages on Bowl.com.
6. USBC average rules 319-A #2, 319B, 319D and 319E are waived. The 10-pin rule does not apply. USBC rule 219A, parts 1, 3, 4 and 5 will apply. USBC tournament rules will apply except for exceptions noted above. Club officers will comprise Tournament Committee.
7. Check in will open at Noon. **Bowlers must check in no later than 12:45 p.m.** Meeting will start at 1:00 p.m. Total entry fee must accompany entry form. Make checks payable to Polk County 500 Club. A \$10 fee will be charged for checks returned plus any bank charges, and cash must be paid prior to bowling. No entry fees will be refunded after April 27, 2010.

Dues for the 2010-2011 Season are now due.

ANNUAL DUES ARE \$2.00 per person.

You can tell if you owe dues by looking at the mailing label on your envelope. If the label reads 5/01/10 then your dues of \$2.00 are due this year. If the label reads 5/01/09, then you owe \$4.00 for two years. You can mail your dues to Diana even if you are not entering this tournament this year.
